Syria: A Humanitarian Imperative

Like you, I saw the image of the child on the beach recently. His lifeless body carried by a soldier. The same size as my sons.

A friend of mine called the image unbearable. I agreed. I couldn't look again and couldn't sleep. Instead I went for a walk,

despairing at what Alan and the Kurdi family have suffered, and knowing they are not the only ones. The night was warm, with a clear moon over Lake Ontario. It was peaceful and beautiful; that only made things worse. I returned home, sat beside my

three small children as they slept, and then I went to work.

Because you and I are all part of the Red Cross; we don't look away. No matter how awful things are, our promise is that we will care. No matter what race, colour, gender or religion, our mission is to help the vulnerable. This promise is who we are. It's why our staff and volunteers work everyday to provide support and comfort to those who need it most. It is called the humanitarian imperative - the deepest part of all of us, our best nature. This instinct to reach out to hold. comfort and care.

We have been working with the Red Cross and Red Crescent operations in Syria and neighbouring countries for years to raise funds to help those affected by the conflict. But, after that day, our efforts intensified. This is a new phase - an escalation with new needs.

We are uniquely placed to support these refugees: where other organizations have to start from scratch, we can scale up. Thousands of trained volunteers are ready and agreements with governments, which allow us to operate locally, are already in place.



Lois Hodgins: Why I chose to help

I began working with the Quinte branch of the Canadian Red Cross, in Belleville, Ontario in July of 2004. During my job interview, I was asked, "what do you know about the Red Cross?"

I replied, "I am old enough to have been a Junior Red Cross member in elementary school and was born in a Red Cross hospital. I was born to be involved in the Red Cross!"

I started out as the Community Services Coordinator for the Quinte Branch and participated in Disaster Management and First Aid courses. In those early days, I was nervous speaking with the media about disasters the Red Cross was actively

responding to. That came to a sudden end when a tsunami hit Southeast Asia on December 26, 2004.

We worked 12 hour days, seven days a week for more than three weeks. The outpouring of support from our donors was amazing.

I experienced in a big way what the Red Cross is all about. To be a part of a global effort, delivering aid to those in need wherever they are in the world, is humbling. If there is a Will, there is a way

We "click yes" daily to accept terms that bind us in contract. We readily sign waivers at gyms and promise eternity to mobile companies in fine print contracts. Yet attesting to our wishes in a Will seems to be something better done tomorrow, next week or even next month.

Through this article, we hope to encourage people of all ages to contemplate the contents of their last Will and testament. In many ways, your Will is the most important legal document you will ever sign. It clearly communicates to your loved ones your wishes with respect to the disposition of your property, who you wish to administer your estate on your behalf, and who you wish to have as guardian of your children or dependents.

It does not matter how young or old you are, or how much or how little of an estate you believe you have; this document is the road map for those who will be trying desperately to navigate the estate process. It is called your "Will" because it is just that - your wishes to protect those you love. We will also note that, in our experience, grey areas and ambiguity as to what you would have wanted are fertile grounds for disputes when loved ones are grieving (and we will leave it at that).

Creating a Will does not have to be a scary, expensive or onerous process. We encourage individuals to seek independentlegaladvicetoensuretheir Will is valid so that their wishes, once set, will be honoured. Unfortunately, we have seen circumstances where the legal requirements for the creation of a Will were not met, and therefore the Will is difficult to enforce.

As members of the estate team at the Red Cross, we have to mention how the Canadian Red Cross manages and administers Wills. If you are contemplating philanthropy as part of your legacy, there are certain ways you can phrase and structure your Gift to maximize its impact on our charitable work. Simple things can make a world of difference.

If you choose to name us as a beneficiary, we encourage you to name us as "The Canadian Red Cross Society," as opposed to a provincial region of the Red Cross, as this is our full legal name. We have seen instances where charities have had to go through the court process to prove that the intent of the testator was for their particular charity.

General Gifts are always appreciated. We want to honour the testator's connection with the Red Cross, and general expressions of where you want the funds to go are, of course, up to the testator.

As our programs and work can change over time, the more general the expression of the restriction, the better from an administrative perspective. This allows for the Gift to be used as effectively and efficiently as possible.

For all those individuals who remember the Red Cross through any means, we wish to express our heartfelt appreciation for their Gifts - both big and small. Every Gift and every legacy makes a difference and furthers our mission to alleviate human suffering. The estate team is always touched to learn about the personalities, lives and wishes of those who leave us a legacy Gift through their obituaries, Wills, family and executor(s).

In her 20 years as a dedicated Red Cross Volunteer, it's a ritual that has become familiar to her. Her role in Disaster Management has taken

her across the globe assisting wherever she is needed. Ella looks out the small window, watching the Toronto skyline slowly disappear as the plane begins the long journey to Pakistan.

Despite the unrest at her destination,


to her fellow passengers, she is a beacon of happiness. Apart from her briefcase overflowing with papers, Ella looks calm and collected.
